## CONCERNING

THE APPOINTMENT OF THE MORAL ETHICS COMMITTEE  
OF INSTITUT PENDIDIKAN INDONESIA GARUT

RECTOR OF INSTITUT PENDIDIKAN INDONESIA GARUT

Considering:

- a. That in order to realize educators who are virtuous, of noble character, cultured, and responsible in carrying out the *Tri Dharma* of higher education as well as in their daily conduct within the environment of Institut Pendidikan Indonesia Garut, it is deemed necessary to establish a committee in the form of a Moral Ethics Committee to ensure and uphold these objectives;
- b. That based on the consideration referred to in point (a), it is therefore necessary to stipulate a Rector's Decree on the Appointment of the Moral Ethics Committee of Institut Pendidikan Indonesia Garut.

HAS DECIDED:

- To Stipulate : RECTOR'S DECREE OF THE INSTITUT PENDIDIKAN INDONESIA GARUT CONCERNING THE APPOINTMENT OF THE MORAL ETHICS COMMITTEE
- FIRST : To appoint individuals whose names are listed in the Attachment, which forms an integral part of this Decree, as members of the Moral Ethics Committee of Institut Pendidikan Indonesia Garut;
- SECOND : The Moral Ethics Committee as referred to in Dictum FIRST shall have the following duties and responsibilities:
1. Ensure that lecturers uphold moral integrity and ethics in carrying out their professional responsibilities.
  2. Ensure that lecturers are not involved in activities leading to violations of law or morality, sexual harassment, bullying, corruption, possession of sharp weapons or firearms, and distribution or consumption of narcotics.
  3. Ensure that lecturers exercise their professional duties properly and do not neglect or misuse those responsibilities toward the institution, fellow lecturers, students, society, or themselves.
  4. Ensure that lecturers do not request or accept any form of compensation in guiding or assessing students' academic achievements.
  5. Ensure that lecturers do not engage in academic misconduct, including plagiarism and other unethical academic actions.
  6. Ensure that lecturers do not participate in acts that damage facilities, infrastructure, or properties within the environment of Institut Pendidikan Indonesia Garut;
- THIRD : This Decree shall take effect as of the date of its stipulation. Should there be any errors or matters that require further regulation, appropriate revisions or adjustments shall be made accordingly.
